

District 52 Meeting Minutes -

District 52 Meeting Minutes June 19, 2025

In attendance; Steve B, Gabriel H, Steve K, Bob L, Kathy P, Steve R, Kris S, and Karli T.

Steve R. called the meeting to order at 6:33 p.m., Steve K. read the 12 traditions.

Secretary's report: There currently is no secretary. The minutes from the May 15th meeting were reviewed by all in attendance. Steve K. asked for clarification on wording in the GSR reports, Steve R. noted that the minutes were recorded verbatim. Kris S. motioned to accept the minutes as typed, Bob L. seconded the motion. Approved unanimously by all in attendance.

Treasurer's report: Bob L. noted that the only mail received was the bank statement. The answering service was paid and \$1063.30 was expended for Sherry's literature purchase (2 cases of BBs, 2 cases of 12&12s, and pamphlets for the FAQ Workshop). Bob does not have the system up and running yet (life on life's terms) but all bills are paid and any funds received have been deposited. Steve B. motioned to accept the report as given, Karli T. seconded. Approved unanimously.

Steve B. read Concept 5 and presented his interpretation; Steve K. added comments related to his experience, strength, and hope then Kris contributed hers as well before Steve R. also noted his take.

Bob L. read Concept 6 and presented his interpretation; Kris shared about her experience, strength and hope.

GSR Reports

Woman to Woman – Karli picked up schedules from Kris tonight. The group needs 3-5 BBs and 3-5 12&12s when they come in, plus newcomer packets. The meeting gets 8-12 members attending regularly.

1st Things 1st - Steve B. reported that attendance is down a little bit but good.

Men's Group - Steve B. noted that they are seeing rollercoaster attendance at this meeting.

S.O.S. – Bob L. shared that attendance is off the charts, upwards of 30 regular attendees; tonight, there were 4 newcomers, anniversary coins were disbursed. The group is hosting the F.A.Q. Workshop at 11 a.m. on Saturday, June 28th at Our Savior Lutheran Church on Brookmont; event funds from the district will be disbursed. Karli asked if she can set up a Grapevine display; Bob said they have limited space but she is welcome to distribute info wherever she can settle in.

New Hope – Gabriel H. said the meeting is still pretty full; need a chairperson for the next quarter; have plenty of literature for sale.

Open Air Beckman Park – Kris S. on behalf of William mentioned they have a new GSR and the group is processing the paperwork to update GSO records.

Lost Sheep – Kathy P. stated that the picnic was a great success and she expressed her gratitude for everyone's support. Meeting attendance is the same. She needs to check if the Monday meeting info has been updated in the schedule yet.

Saturday Night Open – Steve R. mentioned that meeting attendance numbers are down a little bit from low 30s to low 20s; good participation and good newcomer attendance with a good shot at finding a sponsor.

Committee Reports

Literature – Steve K., as Alternate chair, reported we will have literature for sale at the Kankakee Area Mini Conference. He has not been in contact with Sherry for any further updates.

Archives – Kris S. reported that she attended the Area Archives Committee meeting and started online training. The Area Committee is hosting a workshop for new Archivists to establish a template for file management numbering and tracking systems and, once she is able to develop this, will need a committee to implement it; several members present at tonight's meeting offered to help. Kris received a replacement microcassette recorder and looks forward to obtaining oral histories, especially from long-time members. She has also acquired some materials for updating records storage. Kris plans to record video and take pictures of the archives display at International Convention.

Answering service – Bob L., on behalf of William, reported that there was 1 call received in April to the men's line and 0 calls received to the women's line; 0 calls were received on either line in May.

Treatment – Bob L., on behalf of Adria, reported that she couldn't make it due to car trouble but she is keeping the roll call going at the St. Mary's Ascension/Prime meeting on Wednesday mornings, at Banyan on Wednesday mornings, at Bridging the Gap, and at Brandon House.

Accessibilities – Steve B. asked if anyone knows of anybody who has special needs. Do we know how to make groups/locations more accessible without mandating "renovations"? Should he print up something with his name and phone number on it to distribute to groups, in case they have requests? Kris suggested he get connected with the Area Accessibilities Committee; Bob suggested contacting the local Chamber of Commerce to see how the community can support; Karli offered to help Steve get connected with AA resources.

Grapevine – Karli reported that the GV dropbox is doing well; she awarded 1 winner in May and 2 winners, so far, in June. She started an e-mail distribution list for the GV newsletter, which includes a QR code for accessing past issues. All GV resources are now linked in the digital copy of the newsletter and she is adding links to the GV newsletters for surrounding districts. Karli reached out to the GV coordinator at GSO to ask about including a copyright disclaimer for republished articles/etc. and they confirmed it's prudent to have one; Karli will add it to all future issues of our GV newsletter. The "From the Vineyard" page in the Link is coming along and she has started sharing it on the D52 website.

The table she set up at the Lost Sheep picnic was well-received and she had several inquiries about accepting credit card payments for literature; she's looking into using Zelle and/or Paypal, etc. Karli is attending Saturday's Area Assembly and looking forward to sharing her progress and results with them.

The Kankakee Alano Club Literature Committee had pre-owned GV books that they offered for her to take; she accepted them and is going to use them at the new "Raisin Hope" Grapevine meeting starting Monday, July 7th at 5:30 p.m.; the meeting will mostly read Grapevine books and the magazine but will also offer quarterly writing workshops. If D52 needs groups to host a workshop, Karli assures that the Raisin Hope meeting is happy to do so!

Newsletter - Scott O. was not in attendance. No report.

PI/CPC - Earl was not in attendance. No report.

Webmaster - Lauren was not in attendance. No report.

- Bob already mentioned the F.A.Q. Workshop

- No new nominations to fill empty positions.
- How can we get more people involved as GSR and in attendance at the district meeting?
- As Bill Sees It group has requested 4-6 copies of the book to support their growing attendance. Discussion about how past requests were handled; concerns about setting a precedent; recommended everyone take it back to their groups to see if a better-off group is willing to help those in need; Kris said she will donate the books to them. Kris motioned to implement a standard policy that District 52 does not fund group literature. Bob offered a friendly amendment to exclude Big Books and 12 & 12s designated for newcomers. Karli seconded the amended motion. 7 members present voted to approve the motion, as amended; 1 member opposed. Minority opinion was expressed and votes were recast. 7 approved, 1 opposed. Motion passed.
