September 18, 2025

In attendance: Steve R., Karli T., Tanya, Stacy W., Gary, William K., Adria P., Bob L., Kris S., Sherry M., Steve B.

Steve R. called the meeting to order at 6:30 pm and William K. read the Twelve Traditions.

Secretary's report: Stacy reported there are no minutes for last meeting.

Treasurer's report: Bob L. noted that the current bank balance is 2,913.76 which includes \$200.00 deposited from the golf outing and \$19 deposited from the 7<sup>th</sup> tradition at last month's district meeting. Bob noted that there was an expense for the answering service in the amount of \$41.30 that was paid. We received a late notice letter for our not-for-profit corporation act paperwork. On 01/10/25 we had 90 days to complete the paperwork and send it back. Letter was mailed to Heather S, and she just gave it to Bob. Kris S. noted that the letter is pertaining to the 990 N, and it should have been given to the treasurer to complete per the SOP. Bob is completing paperwork and sending a check. Stacy W. motioned to accept the report as given and William K seconded. Approved unanimously.

Bob L read Concept 9 and presented his interpretation.

#### **GSR Reports**

Steve R. mentioned that he thought that was part of what the answering service was for, and Kris agreed and stated she has gotten those calls as well. Steve R. will be adding the Bridging the Gap committed to the roster so we can try to find a chairperson.

Archives – Kris S. mentioned that she received a tablet that she plans to use to display digital archives at different events starting with the mini conference. You Tube has videos of the NY archives that are cool. Kris also reported that she is now the alternate area archives chair.
